- 1. Please complete all information on the form. The nominee may also provide this information. Attach additional sheet(s) if necessary.
- 2. A bowler may be nominated for Bowling Achievement or Meritorious Service or both. A bowler is eligible to receive one of each type of these awards in their lifetime.
- 3. A bowler must have been a member in good standing with the West Volusia USBC Bowling Association for at least 10 years. Membership in prior West Volusia Bowling Associations (ABC, WIBC, YABA) may be included.
- 4. For Bowling Achievement, a bowler must have shown continuous outstanding achievements in the field of bowling. Numerous achievements would be expected for a bowler to be worthy of consideration. Some examples are listed as follows:
 - a. Has been a member of a West Volusia USBC Association City Tournament Championship team
 - b. Has won a West Volusia USBC City Tournament Doubles, Singles or All Events
 - c. Has won any West Volusia USBC Bowling Association tournament
 - d. Has bowled high game and series, such as USBC honor scores
 - e. Has maintained a high average
- 5. For Meritorious Service, a bowler must have gone above and beyond the call to promote bowling. Some examples are listed as follows:
 - a. Has attended all West Volusia USBC Bowling Association meetings
 - b. Has made admirable contributions to the West Volusia USBC Bowling Association
 - c. Has demonstrated outstanding leadership
 - d. Has participated in local tournaments
 - e. Has promoted the activities of the West Volusia USBC Bowling Association
- 6. Anyone can nominate a person for any of the awards. Self-nominations are also allowed.
- 7. Nominations may be submitted to the West Volusia USBC Bowling Association at the listed address at any time during the bowling year. The Association's Awards Committee will make a recommendation to the Board of Directors for approval. The decisions should be kept confidential.
