WEST VOLUSIA 500 CLUB TOURNAMENT RULES

- 1. The tournament is open only to current members of the West Volusia 500 Club who renew their 2024-2025 dues (\$3.00), and a current USBC card. Annual dues (if not already paid) must be paid along with tournament entry fees.
- 2. Handicap will be 100% of 200
- 3. It will be a sanctioned tournament
- 4. Entrants shall use their highest USBC sanctioned league average as of the end of the 2023-2024 season, provided they have 21 games or more. If no average is available for the 2024-2025 season, bowler may use current average of 21 games for the current season as December 31, 2024. Entrant must use highest sanctioned average regardless of whether entrant bowled as a regular member or a substitute.

 ALL WINNERS AVERAGES ARE SUBJECT TO FURTHER VERIFICATION BY THE TOURNAMENT DIRECTOR. IF NONE OF THE ABOVE IS AVAILABLE, ENTRANT WILL BOWL SCRATCH.
- 5. USBC Rule 319a (1 & 2) (10 pin rule) and USBC Rule 319a/3 and 319c (verification of average & re-rating) APPLY.
- 6. Rule 319d DOES NOT APPLY
- 7. In the event of a tie, the tournament management will declare co-champions. The money for first and second place will be added together and evenly divided between the two bowlers.
- 8. The tournament committee will rule on anything not covered by these USBC Tournament Rules. All decisions of the tournament management are final, unless an appeal is made in accordance with USBC Rule 329. The tournament committee is the West Volusia 500 Club Officers and Board of Directors.
- 9. All prize money will be returned 100% at the ratio of at least one prize for each five entries.
- 10. The winner in each division shall have their participation fee reimbursed by WV 500 Club for the 2025 Florida 500 Tournament held in Ocala, Fl. A copy of the tournament recap sheet must be submitted to receive reimbursement. In the event the first-place winner is unable to participate in the Florida 500 Tournament, the bowler with the next highest score will be eligible to take their place.
