Tournament Rules

1. This tournament is open to all sanctioned and non-sanctioned bowlers.
2. **Bowlers who are members of a USBC Association outside of West Volusia USBC are eligible to bowl and no local membership with West Volusia USBC is required. Proof of average, as defined in rule #7 below, MUST be provided by the bowler prior to bowling.**
3. This tournament is handicap, 90% of 220, for all bowlers. There will be 2 divisions with separate prize funds, MEN and WOMEN Divisions.
4. This tournament will be Saturday, July 26, 2025 will be a three (3) game event at AMF Deltona Lanes starting at 2 p.m..
5. There are NO Doubles or Teams in this event.
6. The postmark deadline for mail-in entries is July 22, 2025. Walk-in entries will be accepted on the day of the tournament. Bowlers and walk-in entries must check in at least 30 minutes prior to bowling.
7. **Entering averages:**
 - a. Highest USBC sanctioned average of at least 21 games from the 2023-2024 yearbook or bowl.com.
 - b. Highest 2024 USBC league summer average of at least 21 games (bowler must provide written proof of this average);
 - c. Highest current 2024-2025 USBC sanctioned average of at least 21 games (bowler must provide written proof of this average);
 - d. Bowlers who were not sanctioned with West Volusia USBC for 2023-2024 can provide written proof of USBC sanctioned 21 game average from the league bowled;
 - e. If none of the above is available, bowler will bowl scratch;
 - f. West Volusia USBC averages will take precedence when bowler has any averages from other associations.
8. Failure to use the proper average shall disqualify scores bowled if submitted average is lower than actual average, thereby resulting in a lower classification for more handicap. Prize winnings shall be based on the submitted average if it is higher than the actual average. Tournament management reserves the right to adjust averages upward or downward if the event verification reveals incorrectly submitted averages.
9. USBC rules 319a-2 (10 pin rule) and USBC Rule 319d (reporting Previous Prize Winnings) and 319e (Average Adjustment for Entry) ARE NOT IN EFFECT. USBC rule 319a-4 (bowler average responsibility and average correction time frame) IS IN EFFECT.
10. Lane Assignments:
 - a. Mail-in/hand-in entries will be assigned lanes by random draw. You may request to be paired with other bowlers.
 - b. Walk-in entries will be assigned lanes that are available after the mail-in entries have been assigned lanes.
11. For the bowling tournament, the \$25 entry fee is divided into two parts: \$11 will go directly to the prize fund and \$14 will be lineage. Payout will be 1 in 4 in each division. THERE WILL BE NO REFUNDS AFTER THE ENTRY CLOSING DATE AND TIME IN THE EVENT OF A NO SHOW AFTER PAID ENTRY FEES. **No CREDIT CARDS will be accepted.**
12. In the event of a tie for first place co-champions will be declared. Any ties will have prize monies combined and divided equally.
13. An imprinted award will be presented to the winners later in the bowling year.
14. Proper attire MUST be worn during tournament bowling! **NO TANK TOPS (minimum short sleeves) OR SHORT SHORTS. IMPROPERLY ATTIRED BOWLERS WILL BE ASKED TO CHANGE OR NOT BE ALLOWED TO BOWL.**
15. United States Bowling Congress (USBC) rules govern this tournament.
