TOURNAMENT RULES

1. This tournament is not sanctioned. No USBC membership is required. It is open to all adult bowlers.
2. Walk-in entries will be accepted on the day of the tournament from 12:00 noon until 1:00 p.m.
3. This tournament will be a three (3) game singles event, using a no-tap format. No-tap strikes will be based on the bowler average as listed in rule #4. Total no-tap scores shall determine standings positions.
4. Men and women bowlers with a verifiable 21 game USBC sanctioned average as listed below that is 160 or under will use 8 counts or 9 counts for strikes. Those with an average that is above 160 will use 9 counts for strikes. Averages are used only for determining 8 or 9 count strikes. Priority of average use is as follows:
  - a. Highest USBC sanctioned average of at least 21 games from the 2023-2024 yearbook;
  - b. Highest 2024 USBC league Summer average of at least 21 games (bowler must provide written proof of this average);
  - c. Highest current 2024-2025 USBC sanctioned average of at least 21 games (bowler must provide written proof of this average);
  - d. Bowlers who were not sanctioned with West Volusia USBC for 2023-2024 can provide written proof of USBC sanctioned 21 game average from the league bowled;
  - e. If none of the above is available, bowler will use 9 count for strikes;
  - f. West Volusia USBC averages will take precedence when bowler has any averages from other associations.
5. There will be separate divisions for men and women, each with a separate prize fund.
6. Bowlers must check in at least 30 minutes prior to bowling.
7. Lane Assignments:
  - a. Mail-in entries will be assigned lanes by random draw. You may request to bowl with specific bowlers, but the entry forms must be received together.
  - b. Walk-in entries will be assigned lanes that are available after the mail-in entries have been assigned lanes.
8. The deadline for hand-in and mail-in entries is April 23, 2025. Bowlers wanting to bowl with specific other bowlers must submit all entry forms together by this date. If walking-in to register, have everyone register together. There is no guarantee walk-in registrations can be paired with specific bowlers.
9. Prize money will be returned 100%. Payout is 1 for every 5 entries in each division. There will be \$100 added money to each division.
10. In the event of a tie for any position, the prize money will be combined and divided equally.
11. Proper bowling attire is requested. No tank tops or short shorts, please.
12. Optional Brackets will be offered at \$5.00 per bracket.
13. There will be no refunds after the entry closing date in the event of a no-show after having paid entry fees. A written request with an explanation to the West Volusia USBC Board of Directors can be made to request an exception.
14. Payments can be either cash or check. Please make checks payable to WVUSBC and mail entry form and fees by April 23 to:
